A member of the public confirmed that they wished to know Council's view on the Bloods Hill proposals.

PC/014/25-26 To discuss 'proposals' for new homes and public open space on land at Bloods Hill, to the east pf Kirby Muxloe

In addition to the previous observations made, it was noted that

- Traffic models for Kirby Muxloe, Ratby and Leicester Forest East are required
- Infrastructure is required from the offset, not during or after the development.
- The bridge is too narrow for two lorries to pass and furthermore there is no public footpath
- While the Primary School already exceeds capacity, this is constrained by the current site.

- The Roundhill application needs to be highlighted
- A water survey is required, due to flooding twice within the past eighteen months. The Railway line was highlighted, due to the importance of the mineral traffic
- All 6-8 proposals/developments in and around Kirby Muxloe need to be taken into consideration in their entirety, all of which would place severe strain on the resources.
- Kirby Muxloe is particularly distinctive and Blaby District Council must support that.
- A noise survey is required
- The market value of existing properties will decrease
