ii. To fill and water 30 summer hanging baskets for a further two years
A quotation to fill and water 30 summer hanging baskets for a further two years
was received and it was noted that this included a 15% discount for year 2 and a
17.5% discount for year 3.

It was **RESOLVED** that the quotation to fill and water 30 summer hanging baskets for a further two years at a cost of £3,391.50 (Year 2) and £3,291.75 (Year 3) be APPROVED.

iii. For fencing around the pond

Three quotations to replace the fencing around the pond were received and it was noted that all quotations included fencing of 1.1m high and with slats 10cm apart in order to comply with current regulations.
