flags being displayed, providing this is done legally. However, those which pose a risk will be removed and it was also noted that roundabouts

are being cleaned immediately.

In relation to Local Government Reorganisation (LGR), it was advised that business modelling is being prepared in the background. County Cllr K Crook also noted that he wishes to interact with individual parishes to establish which powers they want to use going forward.

After some discussion, it was AGREED that attention be drawn to point 12.8 of the TP1, which specifies that the Parish will not own the boundary hedge, while noting that the plan is more open to interpretation.

iii. Developing Kirby Muxloe

It was **RESOLVED** that a Working Party be established consisting of Cllrs N Bruen, D Everley, M Fox, M Mulholland and F Quilliam and AGREED that draft Terms of Reference be considered at the next meeting,

iv. Joining 'Villages Together'

A Community Statement from Villages Together (a coalition of Parish Councils) was circulated.

PROPOSED by Cllr M Fox and SECONDED by Cllr F Quilliam

It was **RESOLVED** that Kirby Muxloe Parish Council join 'Villages Together' and that Cllr C Frost be the nominated Representative.

Members reconsidered the four quotations.

ii. To undertake additional tasks highlighted in the Annual Safety Inspection Report

A repair to the base underneath the shelter seating was highlighted.

A quotation of £650 was received, which reflected an alternative option.



Further to consideration, members AGREED to seek further options/quotations.

A quotation (£460) to eliminate the gaps around the seesaw and to tighten bolts on the climber tower were presented

PROPOSED by Cllr C Frost and SECONDED by Cllr N Bruen

It was **RESOLVED** to proceed with the quotation at a cost of £460

iii. Replacing two posts by the MUGA

Members were advised that quotations for alternative options are still awaited.

The Clerk highlighted that an inspection has been undertaken at The Byways, which was found to be very cluttered. Mould was reported to be an issue, which a previous Report concluded was due to a lack of ventilation. The plug socket behind the refrigerator has also stopped working.

Leicestershire County Council have addressed the hedge by The Red Cow on this occasion and the Clerk advised that a resident of the BUPA Care Home very much appreciated this.
