**TEMPORARY TRAFFIC REGULATION ORDER**

**TAY ROAD, LUBBESTHORPE**

Leicestershire County Council Highways has agreed to a Temporary Traffic Regulation Order at the above location.

A road closure is required on Tay Road commencing at 18:00 on Friday 9<sup>th</sup> July until 17:00 on Sunday 11<sup>th</sup> July.

The Temporary Traffic Regulation Order will be implemented for public safety for C3 Construction Ltd to undertake various infrastructure improvements.

The proposed alternative diversion route will be via: Beggars Lane, Hinckley Road, Leicester Forest East, Braunstone Way, Leicester City; Lubbesthorpe Way, Meridian Way, Braunstone; Tay Road, Lubbesthorpe and vice versa.

### **CHURCH ROAD, KIRBY MUXLOE**
