iii. Fencing backing onto the Play Area

After some discussion, it was anticipated that good quality fencing be placed around the perimeter of the Play Area (Station Road/Barwell Lane) at the appropriate time.

In the meantime, the Clerk was requested to contact the properties backing onto the Play Area in relation to their boundary fencing.

iv. Gaining a quotation for debris deposited in undergrowth around the perimeter of the Play Area

It was **RESOLVED** that quotations for the brash to initially be cut away to enable the debris to be removed, with the second stage revolving around the shrubs, be obtained.

v. A quotation for clearing the brook
